

PEDESTRIAN CROSSING SIGN INSTALLATION AND MAINTENANCE AGREEMENT

This Pedestrian Crossing Sign Installation and Maintenance Agreement is entered into on this _____ day of _____, 2026, by and between the City of Manitowoc, Wisconsin, a Wisconsin Municipal Corporation (hereinafter "City") located at 900 Quay Street, Manitowoc, Wisconsin 54220, and Manitowoc Public School District (MPSD) (hereinafter "MPSD") a Wisconsin institution of learning with a mailing address of 2902 Lindbergh Drive, Manitowoc, Wisconsin 54221-1657.

WHEREAS, MPSD desires the installation of Rectangular Rapid Flashing Beacons ("RRFB's") Pedestrian Crossing Signs located at South 14th Street and Division Street for the South Crosswalk (Jefferson Elementary School) as identified in Exhibit "A" attached hereby and incorporated by reference; and,

WHEREAS, the purpose of the sign installation is to enhance safety by alerting drivers of the presence of pedestrians crossing at the intersection of S. 14th and Division Street, particularly MPSD staff, students, parents, etc.; and,

WHEREAS, the City has agreed to install Two (2) RRFB Pedestrian Crossing Signs at the south crosswalk of South 14th and Division Street upon the request of MPSD in the interest of safety to MPSD students and parents and the general public upon the terms and conditions of this Agreement; and,

WHEREAS, MPSD agrees to pay the entire cost of furnishing the signs and for the annual maintenance fees for the signs; and,

WHEREAS, the property upon which the signs are to be located is shown on the attached map as Exhibit "A" which is hereby incorporated by reference and is more particularly described as follows:

A location in the right-of-way in the NE ¼ of Section 31, T 19 N., R 24 E., and more particularly described as being located in the City's right-of-way known as South 14th Street and Division Street (South Crosswalk).

NOW, THEREFORE, it is hereby understood and agreed by and between the parties hereto as follows:

ARTICLE I

SIGNS

Section 1. Property. This agreement shall pertain to two (2) solar powered RRFB's pedestrian crossing signs with push button activation at the south crosswalk of South 14th and Division Street.

Section 2. Sign Location. The exact location of the signs shall be determined by the Director of Public Infrastructure/City Engineer for the City in his or her sole discretion. The RRFB lights and signs shall be placed at the south crosswalk of South 14th and Division Street as shown in Exhibit "A". The location of the signs shall be for the purpose of enhancing safety by alerting drivers of the presence of this pedestrian crossing.

Section 3. Ownership and Public Right-of-Way. The sign(s) shall be placed in the public right-of-way, and shall be under the ownership and control of the City, and shall be held for the use of the general public, including any MPSD staff, students and parents, etc.

Section 4. Cost of the Signs and Installation. MPSD shall pay the full cost for furnishing the signs. City shall pay for the cost to install the said signage. Payment for the cost to furnish the signs shall be paid by MPSD within thirty (30) days of receiving the billing statement.

ARTICLE II

TERMS

Section 1. Agreement Term. This Agreement shall become effective immediately upon it's signing by all parties and shall remain in force for forty (40) years. After forty (40) years, this Agreement shall automatically renew on a yearly basis, on January 1st of each year, unless either

party notifies the other within thirty (30) days of the 1st of January their desire to no longer maintain the signs.

Section 2. Payment for Maintenance. MPSD shall be responsible to pay an annual fee for the maintenance of said signs, which maintenance shall be provided by the City. MPSD shall not perform any maintenance to or on the sign(s). If MPSD feels there is a need for maintenance, MPSD shall notify City requesting an inspection of the sign(s) to determine if there is in fact a need for maintenance.

Section 3. Annual Maintenance Fee. The annual maintenance fee shall be **\$150.00 per year**, for the first three (3) years of this Agreement, **commencing on January 1, 2029**, due on or before January 1st of any given year. Beginning with and including 2032, the annual fee shall increase annually on January 1st of each succeeding year \$5.00 per year as long as this Agreement is in effect. There shall be no pro-ratio of the annual fee for any reason.

Section 4. Maintenance Defined. Maintenance shall include all costs for providing a secure sign structure, working push button activation, working RRFB lights, retro-reflective sign face and batteries. Any additional items not specifically noted as maintenance shall be considered repairs/replacement.

Section 5. Repairs and Replacement.

a. **Damage.** In the event of damage, destruction or deterioration of any kind, by any means, to the sign or signs, the City, in its sole discretion, shall determine if the sign(s) shall be repaired or replaced.

b. **Cost of Repairs/Replacement.** If City determines that the sign or signs should be repaired or replaced, it shall do so at MPSD's cost. City shall provide MPSD with ten (10) days written notice in accordance with Article III of this agreement of any proposed repair or replacement of the signs along with an estimate of the cost of any such repairs or replacement.

Any repair or replacement of the signs shall be billed to MPSD on a time and material basis, payable by MPSD within thirty (30) days of receipt of the bill from City.

Section 6. Termination.

a. Termination for Convenience by MPSD. Notwithstanding the provisions of Article II, Section 1 above, MPSD may, at any time following ten (10) years after the execution of this Agreement, terminate this Agreement and any and all of its obligations hereunder at its sole convenience upon providing a thirty (30) day written notice of termination to the City in accordance with Article III of this Agreement. Upon notification, it shall be in the City's sole discretion to determine whether the signs shall remain in place or be removed, at no further cost to MPSD.

b. Termination for Cause by The City. The City may terminate this Agreement at any time upon thirty (30) days written notice to MPSD in accordance with Article III of this Agreement if the City, in its sole discretion, determines the signs create a hazard or the signs are in violation of any Local, State or Federal Law.

c. Default and Termination. If either party fails to perform or observe any material term or condition of this Agreement, then such party would be in default of the Agreement and the non-defaulting party may terminate the Agreement. The party seeking to terminate the Agreement must provide written notice of default to the defaulting party. This written notice must specify the default(s) giving rise to the right to terminate the Agreement. The defaulting party will have thirty (30) days to cure the default(s) unless such cure period is extended by agreement of the parties. If the default is not cured within this thirty (30) day period or any extension thereof, then the Agreement will automatically terminate.

ARTICLE III

NOTICE

All notice required or otherwise given hereunder shall be in writing and delivered personally or by registered mail. All mailed notice shall require proof of acknowledgement of receipt of said notice and addressed, as the case may be, to the respective party as addressed below:

Either party may change the address to which notice is to be given by notifying the other party, in writing, of such a change.

ARTICLE IV

APPLICABLE LAW

This agreement shall be deemed to have been made in Manitowoc County, Wisconsin and shall be governed by and construed under, and enforced in accordance with, the laws of the State of Wisconsin. All actions or proceedings relating directly or indirectly to this Agreement, whether sounding in contract or tort, shall be litigated only in the Circuit Court located in Manitowoc County, Wisconsin. All parties to this Agreement hereby subject themselves to the jurisdiction of the Circuit Court for Manitowoc County, Wisconsin.

ARTICLE V

HEADINGS

The section titles have been inserted in this Agreement primarily for convenience and do not define, limit or construe the contents of such paragraphs. If headings conflict, the text shall control.

ARTICLE VI

RELATIONSHIP OF PARTIES

Nothing in this Agreement, nor any act of City or MPSD, shall be deemed or be construed by the parties hereto or by any third party as creating the relationship of principal and agent or of partnership or of joint venture between City and MPSD.

ARTICLE VII

ASSIGNABILITY

MPSD shall not assign this Agreement or any part of it without the prior written consent of City, which consent shall not be unreasonably withheld.

ARTICLE VIII

MODIFICATION

This is the entire Agreement made this date between the parties and any modification or change shall be in writing, by agreement of the parties and executed with the same formality as this document.

ARTICLE IX

DRAFTING OF AGREEMENT

All parties have contributed to the drafting of this Agreement. In the event of a controversy, dispute or contest over the meaning, interpretation, validity or enforcement of this Agreement or any of its terms or conditions, there shall be no inferences, presumption or

conclusion drawn whatsoever against any party whatsoever by virtue of that party having drafted this Agreement or any portion thereof.

This Agreement shall be dated, effective and binding on the parties as of the date of the last execution.

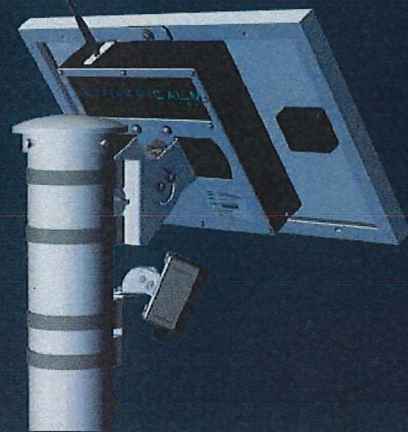

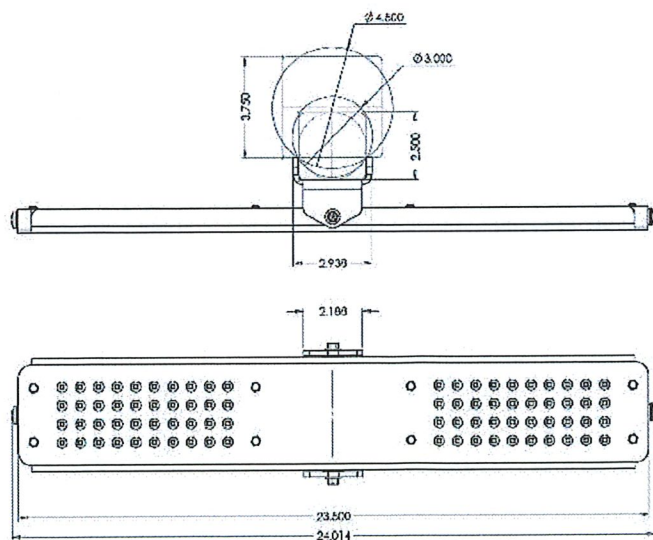

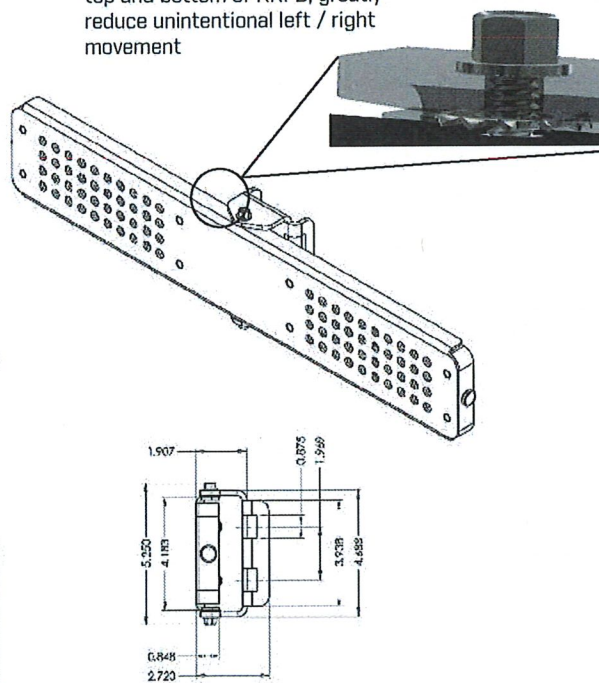
