

**RESOLUTION TO ENTER INTO A JURISDICTIONAL TRANSFER WITH  
MANITOWOC COUNTY FOR CTY TRK HWY “R” (A/K/A NORTH RAPIDS ROAD)  
IN THE TOWN OF MANITOWOC RAPIDS AND CITY OF MANITOWOC  
(County Trunk Highway “P” to Waldo Boulevard)**

**WHEREAS**, the Common Council has been provided with a map that shows a 1.65 mile portion of C.T.H. “R” (N. Rapids Rd.) from C.T.H. “P” (Homestead Road) to Waldo Boulevard identified as number 1 and shown as a red line on said map (“Subject Roadway”); and

**WHEREAS**, while the Subject Roadway is part of the County Trunk Highway system, it is located in the City of Manitowoc (“City”) and the town of Manitowoc Rapids (“town”); and

**WHEREAS**, Manitowoc County has agreed to fund and manage a major construction project on the Subject Roadway in 2024; and

**WHEREAS**, the City, Manitowoc County and the town have determined that it is in the public interest to transfer jurisdiction and maintenance of the Subject Roadway to the City and town; and

**WHEREAS**, the town accepted the transfer of an approximately 0.25 mile section of the Subject Roadway from the Manitowoc County in its jurisdiction on December 13, 2023; and

**WHEREAS**, the town has agreed to pay the City annually for its portion (0.25 mile) of General Transportation Aids for the section of the Subject Roadway in its jurisdiction in exchange for the City agreeing to perform all maintenance and access and utility permitting on the roadway; and

**WHEREAS**, the City has agreed in principle to accept the transfer of the other approximately 1.40 miles of the Subject Roadway that lies within its jurisdiction; and

**WHEREAS**, the City will take over all maintenance and access and utility permitting in the 1.40 mile section of the Subject Roadway transferred to it on October 1, 2024.

**NOW THEREFORE BE IT RESOLVED** that the Mayor and Common Council members of the City of Manitowoc authorize the jurisdictional transfer to the City that 1.40 mile portion of County Trunk Highway “R” (a/k/a North Rapids Road) that lies within the City’s jurisdiction from County Trunk Highway “P” (Homestead Road) to Waldo Boulevard; and

**BE IT FURTHER RESOLVED** that the Mayor and Common Council of the City of Manitowoc authorize such City of Manitowoc officials as necessary to enter into a Jurisdictional Transfer Agreement with Manitowoc County transferring that 1.40 mile portion of County Trunk Highway “R” (a/k/a North Rapids Road) that lies within the City’s jurisdiction from County Trunk Highway “P” (Homestead Road) to Waldo Boulevard.

**Fiscal Impact:**

At the time, indeterminate of exact dollar amount of fiscal impact. Anticipated additional revenue to be received in General Transportation Aids from State due to additional road miles being the responsibility of the City. Known expenses that will increase due to the additional road miles being the responsibility of the City are but not limited to: labor/equipment: snow plowing, grass cutting, grading of gravel; materials/supplies: salt/brine for winter maintenance, latex/epoxy paint/service for maintenance of markings; general maintenance expenses associated with roads as time lapses since new construction. It is anticipated expenses will be more than revenue received; however, it is of the opinion of the Finance Director that having the above named section of road under the ownership of the City is in the best interest of the City for control, task management, and consistency.

- ⑥ **W Viebahn St & Hecker Rd (End of W Viebahn to ~ 2,530 feet south on Hecker Rd)**  
Proposed 2024 City Project. Reconstruction with Asphalt (Rural X-Section) Maintenance Agreement Needed.
- ⑦ **Viebahn St (Hecker Rd to I-43)**  
Proposed 2024 City Project. Proposed Jurisdictional Transfer (J.T.)
- ⑧ **Viebahn St (I-43 to Railroad)**  
Proposed Construction Project 2028-2029. Proposed Jurisdictional Transfer (J.T.) Requires working with Town. Proposed Paving Agreement.
- ⑨ **Viebahn St (Railroad to S 10th St)**  
2024 County Mill & Overlay. Proposed Jurisdictional Transfer (J.T.) Requires working with Town.

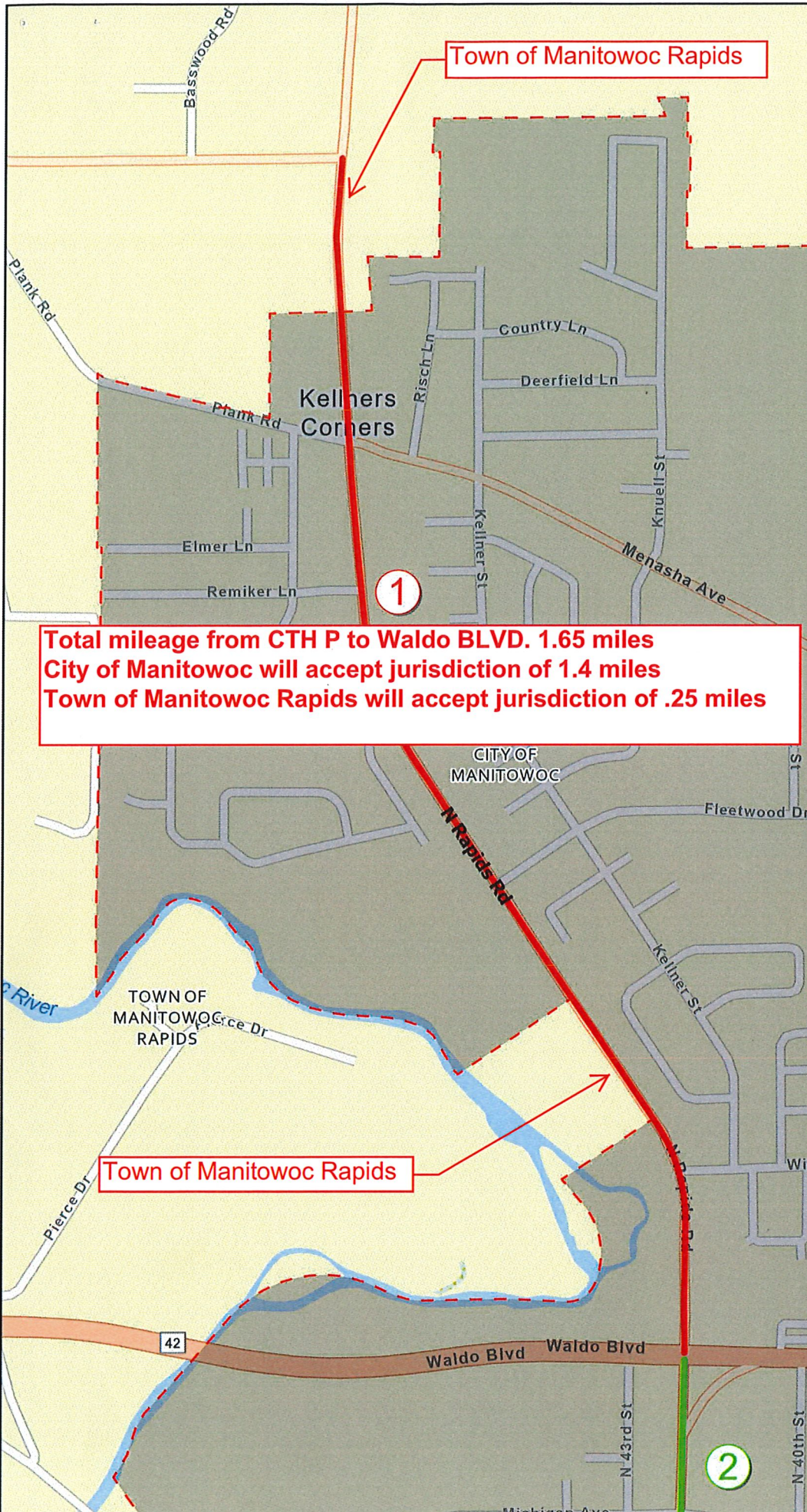
