Good Morning Public Safety Committee –

As I've told you in the past, I would share any concerns from citizens at the intersections affected by the change to 2-way street. Below is a concern.

Alderman Cummings, let me know if you will add this to your next agenda for discussion.

Myself, my husband and our 3 kids live on Huron Street, right behind Retro 8th coffee shop. We are very concerned about the safety of our kids playing outside, along with other drivers at this intersection. Since 8th street was converted to a two-way road, this intersection is uncontrolled and a blind intersection. The intersection of 8th and Huron is so dangerous. This week alone there has been 2 accidents in 3 days, right at this intersection. On average, there is at least 1 car accident every 1-2 weeks. This is a huge hazard and concern for us as residents of Huron St. My husband and I would love to see this looked into and possibly controlled. We don't feel safe allowing our children (middle school and elementary school ages) to play outside at our house. We also do not feel safe even using this intersection to leave or return to our house. We are hoping our concerns are taken seriously. I know we are not the only ones concerned with this intersection. We have a lot of family from out of town that visits and they feel the intersection is unsafe also.
