On courts 1-3, there should be a bench on the right of court 1, a bench in between courts 1 and 2, and a bench to the left of court 3.

On courts 4-6, there should be a bench to the right of court 4, a bench in between courts 4 and 5, and a bench to the left of court 6. On courts 7-8, there should be 2 benches to the right of court 7, and 2 benches to the left on court 8.
