Erika,

Last night, the PI Committee approved our plan to reline the existing culvert crossing on N. Rapids Rd. at Conroe St. at a cost not to exceed \$32,000.

The existing culvert pipe is rusting out. We need to reline the pipe in order to ensure that it does not collapse.

If the pipe collapses, then the roadway will also likely collapse. If it collapses, then relining is no longer an option and the area will have to be open cut, which would mean lane closures and possibly a complete road closure.

We need to have CAWG and the Finance Committee approve this unbudgeted request ASAP as the County would like their contractor to do the work in the next 4-6 weeks. The County has several other locations where they are doing this same type of work.

Is there any way that we could have a Finance Committee Meeting just before the Council Meeting on April 17th to approve this request?
