SCOPE OF SERVICES

Description

As MSA had discussed with the City, the current Lincoln Park Wetland Aviary Zoo project has required additional services completed from MSA to meet the overall project requirements per DNR Guidance. MSA has summarized the additional services as noted below:

Wetland Delineation:

A wetland delineation was never specified in the original contract scope but was completed by MSA to complete DNR permitting requirements. The wetland delineation and report were completed in April and May of 2024 and recorded to the DNR in June of 2024.

Wetland delineation tasks completed by MSA for the above mentioned report:

- Preliminary Desktop Review
 - Review of the WDNR SWDV and existing mapped wetlands.
 - Review of soil data from NRCS and existing topography from latest LIDAR data to determine areas
 of high likelihood of wetland extents.
 - o Review of current and past aerial photography to indicate areas with inundation in dry/wet years
 - Compilation of data into an online map for to assist with field investigation
- Field Investigation:
 - Correspondence with client coordinating site visit
 - o Investigate all identified locations within the project boundary identified during the desktop review
 - o Generate, map, and review sample data points for hydrology, vegetation, and soils.
 - The wetland boundary to be mapped by GIS
 - o Disturbed areas (areas with development) can be especially tricky to determine as they are not in
- Compilation of field findings
 - Post processing is required of both the GPS data and the data forms. Data forms transcribed and recorded according to DNR requirements for reporting.
 - Photo and description for each data form
 - Report writing and summary of findings along with fully mapped wetland boundary and Wetland Delineation figures.
 - Generation of CAD drawing files to be included in bid documents to properly denote found wetland boundaries
- Report attachments submittal to the DNR ePermitting site.
