I had our surveyor, Mike Zimmer, go out there and shoot elevations to determine what sidewalks, curbs, driveways, etc. would need to be removed and replaced in order to make the handicap ramps and crosswalk area ADA compliant.

The school would like to have one signed and painted crosswalk located near the north side of the JFK entrance. I am also unclear if the school is paying for this work or if they are requesting the City to fund these improvements. I believe that issue will be discussed with the committee as well.

I have created 2 separate drawings for the proposed pedestrian crosswalk.

One is a straight crossing or 90 degrees.

The 2<sup>nd</sup> one is an angled or skewed pedestrian crosswalk.

I am rather concerned about the existing tree in front of 1540 S. 9<sup>th</sup> St. The tree or the roots are definitely in conflict with the ramp for the pedestrian crossing. Ideally, it should be removed for the crosswalk regardless of the type of crosswalk we use or which side of the tree it is on.

I think the sight distance for southbound traffic will be OK. The hill does impair the view or sight distance for southbound traffic. There is no way you will see this crosswalk as you cross Division St. heading southbound.

I believe that you could see someone in that proposed crosswalk location from 1520 S. 9<sup>th</sup> St., which is at least 250 feet north of the proposed crosswalk.

According to one of our Engineering Manuals, it showed a stopping sight distance of 200 feet for a 30 mph design speed.

There is no sight distance issue for northbound traffic.

If we are serious about constructing this crosswalk, we will need to have our surveyor shoot elevations of the sidewalk and ramp areas to assure we are meeting the ADA Standards.

We will also need to install the ladder style pavement markings and the Pedestrian Crossing Signage.

The driveway approach into the handicap parking area for the JFK (north side of the building) is in terrible shape. The entire approach should really be replaced.

We will lose the one parking space regardless of the crosswalk location.

I will send the angled crosswalk in a separate email due to file size.
