Mike,

This would have to go to the Public Safety Committee to have them approve an ordinance change to have No Parking – Loading Zone for this Area.

I would support this area being a loading zone for buses and parent pick-up and drop-off.

We would have to watch how this is marked. The way they drew it up my first immediate thought was that this looked like diagonal parking if you are coming in from the east.

It would have a solid line perimeter like they showed and then the diagonals or hatching would be much closer together than a normal parking stall.

If this is what Lutheran wants, I guess we could just forward this e-mail to Amber N. at PD and also ask the Committee Chair if they are OK with putting this on the April 13th or May 11th agenda.

I have also attached a portion of MMC Section 10.390 Parking Prohibited, that would have an example of how it might read. We could add language for buses and pick up and drop off, etc.

The attached example by Washington Middle School on S. 21st St. is not the same though. In that case, it was not hatched so cars can park there at other times when the buses are not there. I do not believe that Lutheran wants this.

The attached example for S. 22nd St. by Shady Lane is better.

Hi Mike,

Per our conversation from a few minutes ago....please see attached.

Again, we aren't necessarily looking for any signage to go with this, just simply some diagonal lines to show the front of the commons as a no parking area. Honestly it doesn't matter to me if the police department would be able to ticket people for parking there; we are really just looking for something to serve as a visual aid to deter people from parking there and rather just using that area as a drop off zone. Note the two red "x"s mark the two commons entrances on the north face of the commons. We were wondering, if we are able to get this lines painted, if they could run from the curve on the west side to the start of the parking lot entry on the east side.

I hope this all makes sense. Please feel free to fire away with any questions you have or clarification you may need...I know my drawing is not to scale and rather rudimentary.
