Jefferson Elementary Principal Lisa Delsman called me regarding the results of their safety audit with the Feds.

They are recommending Stop Signs to be installed on S. 15th St. at Division St. and on S. 15th St. at Manila St.

The area at S. 15th and Division St. is not really a T intersection since their driveway is in line with S. 15th St.

She also told me that all students have to leave via the gate on the south side of the school, so there are many kids crossing Manila St.

Based on our discussion, I told Lisa that I support their request and we will plan to put this request on the June 10 P.S. Comm. meeting agenda.

Thank you for contacting me. I will absolutely call you tomorrow today was a bit hectic and it is now late. We had a pretty intensive safety audit done by a number of DOJ, Marshalls, Troopers, etc and learned a great deal about our building and ways we can improve safety. One of the bigger concerns was the fact that 15th street is an uncontrolled intersection to Division- which runs directly into Jefferson as well as 15th and Manila in the back of the building. They recommended a stop sign at each intersection for a number of reasons- that I can absolutely share with you when I call you. Thanks again.
