School Resource Officer Miranda Check shared that with the freshman class's transition to Lincoln High School, the bus drop-off and pickup location was relocated from South 8th Street to Green Street to better accommodate the increased number of buses. This adjustment has proven beneficial and will remain in place. Consequently, the previous ordinance concerning parking regulations on South 8th Street for buses is now outdated.

The proposed amendment suggests eliminating parking on the east side of South 8th Street, between Columbus Street and Madison Street, from 7:30 a.m. to 4:30 p.m. while Lincoln High School is in session.
