
1. Request to Install a Stop Sign at S. 8th St. and Columbus St. for southbound traffic.

Quite a few years ago (more than 10 I think), the Public Safety Committee/Council ordered that we install No Parking Here to Corner signs at every intersection near the high school. This was done even though State Statutes do not allow parking within 15 feet of a crosswalk.

They wanted it to be a clear reminder for all that you can not park too close to the corners/crosswalks.

As far as the No Parking sign, it only has time restrictions on it, so parking is allowed on the west side of S. 8th St. to the north of Columbus St.
