Request: PC 5-2024: Request to Rename Clay Pit Road to Chiefs Way.


Report: The Chiefs Football Club is requesting to rename Clay Pit Road to Chiefs Way. The item was discussed and recommended for approval at the March 6th, 2024 Public Infrastructure Committee meeting. Public Infrastructure referred the request to the Plan Commission for their input and recommendation. There are no businesses or residences that use the Clay Pit Road address.

Chapter 7.010 below, governs Street Names and Numbers.

"The names and numbers of all streets within the corporate boundaries of the City of Manitowoc shall be indicated on the current map on file in the City Planner's office. New street name designations and changes in street names shall be effectuated by ordinance. Such ordinances shall be kept on file in the office of the City Clerk and the maps in the office of the City Planner shall be changed accordingly. The ordinances themselves, however, shall not be separately printed in the Manitowoc Municipal Code. Street name designations and changes shall be initiated by the City Planner or his/her designee and approved by the Chief of Police, the Fire Chief and the City Engineer. Efforts shall be made to avoid names that will lend confusion to the emergency services or names that are similar to existing street names in the City of Manitowoc or any municipality nearby."

The Chief of Police, Fire Chief and City Engineer are all supportive of the name change.

Recommendation: Approve the Change of Street Name from Clay Pit Road to Chiefs Way.

ORDINANCE

An Ordinance amending Section 7.010 of the Municipal Code entitled: "Street Names and Numbers".

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

SECTION 1: Section 7.010 of the Municipal Code is amended to include the following:

"The street located in the SW ¼ of Section 19, Township 19 North, Range 24 East, City of Manitowoc and beginning at the intersection with S. 21st Street thence westerly 2,100 feet more or less to its terminus be renamed from Clay Pit Road to Chiefs Way, all according to the attached map.

SECTION 2: This Ordinance shall take effect on the date of Common Council adoption.SECTION 3: The City Attorney is authorized to make all appropriate revisions to the Municipal Code as a result of this name change.
