I'm sure you are right, because I've mailed them out when I'm done with the other taxes that are due on the 20<sup>th</sup> for the other states, I just didn't do it this time because I had a handful from other states that weren't due until the 31<sup>st</sup> so I mailed them all at one time. If you look at the check date we processed it on 1/17/23, which means we had them done long before it was due.

I'm taking note of what you are saying below and we won't wait anymore, but I can assure you that

when we processed taxes for this hotel many years ago (2004 – until another company managed it) my boss would always wait until the due date to mail these and we didn't have any issues. No other states have this rule and we are in NJ, WI, IN, IL, MS, and GA. I say that to let you know this was truly NOT intentional. We don't like to pay our taxes late 😒

I'm not sure how other states handle it. As an FYI, I just looked back all the way through 2018 and besides the two times in 2020, we only ever received your payment "late" twice... once on the 1<sup>st</sup> and once on the 3<sup>rd</sup>, both times being right after a weekend so we didn't consider it late. Typically we receive your payment between the 20<sup>th</sup> and the 25<sup>th</sup> and only a few times was it later than that.
